
# Diploma in Strategic Financial Leadership

# **PROGRAMME OVERVIEW**

Become a driver of your organisation's strategic direction and performance, transform your finance role and gain new technical and behavioural skills: this fresh and practical programme will help you to adapt and stay relevant in a business landscape that is volatile and dynamic.

#### WHAT IS THE DIPLOMA IN STRATEGIC BUSINESS FINANCE?

Blending technical expertise with leadership training, the programme draws on a wide range of examples, practice and theory and as such is relevant to any industrial, organisational, or international context.

The syllabus addresses emerging topics that are changing the face of the finance function, including finance business partnership, thriving in uncertainty, strategic thinking, sustainable purpose, and techniques adapted from the tech world (such as agile hybrid working and data analytics.)

#### WHO TAKES THE DIPLOMA IN STRATEGIC BUSINESS FINANCE?

The Diploma in Strategic Financial Leadership has been developed for ambitious finance managers who want to add value to their organisation - and transform their own roles - by updating and implementing strategy, managing business performance, engaging with people and leveraging the latest digital technology.



### **CONTENT OVERVIEW**

Across the six modules, the Diploma in Strategic Financial Leadership combines theory with hands-on practical application of skills to boost the value of your contribution to the business. You will learn how to transform and enrich the content and style of your role, apply your skills to strategy and performance, improve your confidence in human engagement, and harness technology.

#### **HOW YOU STUDY**

Facilitated by an experienced and engaging team, the Diploma in Strategic Financial Leadership is delivered and assessed using a virtual learning environment. Study and learning is guided through a mix of:

- watching self-paced micro-lectures, available on demand
- participating in interactive live sessions streamed online
- preparing an assessed portfolio of reflective learning logs, practical application reports, and a capstone presentation

The portfolio links the key module concepts with real business issues, and provides participants with a tangible output that they can take back and use to advance their role and career.

Our learning management platform, Moodle, hosts all course materials and activities e.g. prerecorded videos, course notes and slides, links to live sessions, and timetables. The platform also allows participants to network and share questions. Material is released on scheduled dates, including the pre-recorded videos to support each module. Participants will have time to review and absorb material before the live session with the course lecturer. These live webinars are streamed and recorded using Zoom, a cloud-based app that works on any device.

#### **HOW YOU ARE ASSESSED**

Participants complete a portfolio of assessed work: two reflective learning logs; two practical application reports; and a final capstone presentation delivered to examiners with questions from the panel. The assessments are weighted as follows:

- 30% Learning logs
- 50% Practical application reports
- 20% Capstone presentation

Participants must achieve 50% or above in each of the learning log and practical application reports to be eligible for the award of the Diploma. The overall pass mark is set at 50% with distinction achieved at 70%.

#### **ACCREDITATIONS AND DESIGNATIONS**

Members of Chartered Accountants Ireland and ICAS will be awarded a Diploma in Strategic Financial Leadership from Chartered Accountants Ireland under the 1966 ICAI Charter Amendment Act. Other participants will be awarded the Diploma in Strategic Financial Leadership by Chartered Accountants Ireland Executive Education DAC.

## CAN I USE THE COURSE TOWARDS MY CPD HOURS?

This programme offers structured and unstructured CPD time. The exact number of hours that can be claimed as CPD will vary for each participant depending on time expended and the requirements of their professional body.

### **ENTRY CRITERIA AND ELIGIBILITY**

This programme has been designed to meet the needs of business and finance managers from a range of backgrounds and in a variety of sectors. We welcome applications from:


- members of Chartered Accountants Ireland, ICAS, and other recognised professional bodies including ACCA, CIMA, CPA, ICAEW

Applicants other than members of Chartered Accountants Ireland may be asked to provide evidence of their professional body, or details demonstrating the relevance of their experience or qualifications to this programme.
